

DATA SUBJECT APPLICATION FORM

1. General Information Regarding Your Right of Petition

In your capacity as the data subject in accordance with Article 11 of the Personal Data Protection Law No. 6698 ("KVKK"), you can apply to our Company, Akfen Turizm Yatırımları ve İşletmecilik Anonim Şirketi (the "Company"), and submit your requests on the following:

- (1) Learning whether your personal data is being processed,
- (2) If your personal data has been processed, requesting information regarding such processing,
- (3) Learning the purpose of processing your personal data and whether such data is used appropriately for the intended purpose,
- (4) Learning the third parties to whom your personal data has been transferred domestically or abroad,
- (5) Requesting correction of your personal data if the data is incomplete or processed incorrectly, and requesting notification of the corrections made in this respect to the third parties to whom the personal data might have been transferred.
- (6) Despite being processed in accordance with the provisions of the KVKK and other applicable laws, in the event where the grounds that require processing of the data are no longer available, requesting deletion, destruction or anonymization of your personal data and requesting notification of such actions made in this respect to the third parties to whom the personal data might have been transferred,
- (7) Filing objection to emergence of any outcome against you by analyzing your processed data exclusively through automated systems,
- (8) Requesting compensation in case you suffer damages due to unlawful processing of your personal data.

Based on Article 13 of the KVKK, our company shall finalize your application as soon as possible and within thirty (30) days at latest, depending on the nature of the request.

2. Application Method

In accordance with article 13 of the KVKK and article 5 of the Communiqué on the Procedures and Principles for Application to the Data Controller, you can submit your requests pursuant to your rights in person in conjunction with the documents documenting your credentials at Kazım Özalp Mahallesi Koza Caddesi No: 22 Çankaya Ankara, send your request via notary public or by employing other methods as specified in the KVKK, or send the relevant form to akfen.turizm@hs03.kep.tr using secure electronic signature.
